CRIC Participation in EU Climate Diplomacy Week in Indonesia 2021

"Ambition and Action": Pekanbaru and Mataram

14 October 2021

A. Background

The last climate report published by the Intergovernmental Panel on Climate Change (IPCC) has once again sounded the <u>climate alarm</u>: Only by reducing greenhouse gas emissions to net-zero by 2050 can we limit global temperature rise to 1.5°C. The report makes clear that the world will continue to warm in the short and long term, and we will continue to feel the impacts of this.

This year again, we have witnessed the grave consequences of not taking action: spreading wildfires in the US, severe floods in Europe, and frequent tropical cyclones in Indonesia - to name a few. The impacts of climate change will worsen in the coming years, and these scenes are going to be our usual news headlines, unless we step up action. We all need to act on our ambition to transform towards a low-carbon and climate resilient future, as early as possible.

There is consensus among scientists that countries have to achieve global net-zero CO2 emissions by mid-century to keep 1.5°C warming within reach, and many major players have already done this and have developed long-term development strategies (LTS) beyond 2030 to ensure this development. The EU have committed to achieving net-zero Emissions by 2050, while Indonesia, has committed to achieve the net-zero target "by 2060or earlier"

However, achieving such an ambitious goal requires a massive and coordinated effort from all parts of society, and transformation of all sectors of our economy. This is the main message for the Climate Diplomacy Week 2021, to showcase that we care, we can, and we do - to start taking action collectively in all parts of society, and we need everyone to be on board to take action as we all have a common interest to keep 1.5°C in reach. Therefore, the themes of "Ambition and Action" will be at the center of the EU - Indonesia Climate Diplomacy Week 2021, which will be held between 11 - 16 October 2021.

Climate Resilient and Inclusive Cities (CRIC) as one of the European Union-funded projects are building the capacity of local governments ten Indonesian cities from 2020-2024 to develop Climate Action Plans. The ten pilot cities have stated and demonstrated their commitments to address climate change through their priority sectors such as: waste management, early warning system and water and sanitation.









To amplify the voices of local governments, CRIC will participate in the EU Climate Diplomacy Week by presenting ambition and action from two of ten CRIC's pilot cities: Pekanbaru and Mataram. Both Mayors of these two cities have shown political commitment to tackle climate change through waste management initiatives. The participation of these two cities in the EU Climate Diplomacy Week will speak volumes about local leadership and actions at the city level to achieve the climate resilience.

Pekanbaru will share the sustainable waste management initiatives, one of which is through community mobilisation and Waste Bank revitalisation. This year, Pekanbaru developed its Waste Management Master Plan as a policy framework that promotes sustainable waste management. The City is pushing forward a major initiative to develop Main Waste Bank and a neighbourhood-level Waste Bank to encourage community participation.

Mataram will share the waste management initiative through waste to energy conversion. As organic waste reaches 70% of the total waste, Mataram aims to convert organic waste to biofuel. In the long run, the initiative seeks to decrease the local budget allocated for street lighting by generating alternative renewable energy.

- Build awareness on the impacts of climate change
- Promote the commitments and actions taken by CRIC's pilot cities in responding to climate change
- Push for collaborative action between stakeholders
- Raise visibility for CRIC Project and its pilot cities in accelerating climate change action
